**DISPLAY PROCEDURES:** Scarecrows can be delivered and displayed at Sehmel Park on 10/5/18 between 12pm - 6pm -or- 10/6/18 between 7 - 9am. No advance delivery of scarecrows prior to 10/5/2018. You may drive onto the field to deliver and set up your Scarecrow, but will need to have set up complete and vehicle removed from field no later than 9am on Saturday, 10/6/2018. Groups will be notified of their location for set-up dependant on category. Entrant must remove the scarecrow at the end of the event (no earlier than 4pm) on 10/6/2018. Please feel free to construct and display your entry in the community prior to the date of the contest.

**NEW! SCARECROW REQUIREMENTS:** **MUST FIT IN 10X10 AREA – NO LARGER!** Must be able to sit or stand on it own props. Construction must be sturdy to withstand elements, such as wind & rain. Bring plastic tarp large enough to cover your entry in case of rain. We will provide you with one hay bale and a laminated sign with your scarecrow name and Family Name/Business/Organization on a yard stake. Judges will be looking for originality, creativity, and **true homemade scarecrow builds.**

**SCARECROW RESTRICTIONS:** No religious or political and controversial situations. Must be in good taste (decision the sole discretion of PenMet Parks).
